



## **TYPES OF FINANCIAL AID ASSOCIATE OF SCIENCE IN NURSING PROGRAM**

St. Joseph School of Nursing Associate of Science in Nursing Program participates in federal funding programs such as the Federal Direct Pell Grant, Federal Direct subsidized and unsubsidized Stafford loans, and the Federal Direct Plus loan, to help students cover the cost of their education.

The information below indicates how much a student may be eligible to receive in federal aid for the duration of the program.

**HOW TO APPLY & ELIGIBILITY:** to be eligible for any of the Federal Aid programs a student must:

- Be a US citizen or legal permanent resident
- Be admitted to the program
- Complete the 2010/2011 Free Application for Federal Student Aid (FAFSA) using your completed 2009 IRS income tax returns (if you are a dependent, you need to have your parent's 2009 IRS income tax returns) on line at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). **Our federal school code is 015016.** Note: If you have any problems completing the FAFSA, call 1-800-433-3243 for customer support.
- Be enrolled at least half time (6 credits)
- Not be in default or owe a refund on a federal grant or loan
- Have financial need as determined by established federal formulas when the student has completed the FAFSA form.

#### **Additional aid not administered by the financial aid office:**

State Scholarships are funded and awarded by the state in which the student resides. The deadlines and other requirements are set by each individual state and must be met in order to be eligible for grants. The state grant office usually notifies students of their eligibility when they apply using the free federal form.

Private loan programs allow students to borrow additional funds to pay for educational expenses not covered by financial aid.
